Title, Tables, Name, Author, Work, Management, Academy, Numbers, Author, Headlines, Newspaper, Style, Guide, Journals.aomonline.org Academy of Management Journal STYLE GUIDE FOR AUTHOR REFERENCES are your entries in the alphabetical list at the end of your article. Do not number your reference records. This list should only include work you have quoted. OrderAlphabetize references by the last name of a single author, first author, or editor, or by the name of a business writer (such as the U.S. Census Bureau) or periodic (such as the Wall Street Journal) if there is no human writer or editor. Order works by an identical author after years of publication, list the earliest first. If the years of publication are also the same, differentiate entries by adding lowercase letters (a, b, etc.) after the years. Repeat the author's name for each record. BooksFollow this form: Last name, initials (separated by a space). Years. Title (Boldface italic, capitalize only the first letter of the first word and of the first word after a long dash or colon.) Place where published: Publisher name. (For small U.S. and Canadian cities, follow the name of the city by the post abbreviation for the state or province; for small towns in other countries, give the full name of the country.) What are references? Referencing is a standardized way to recognize the sources of information and ideas you've used in your document. Why reference? Referencing is important to avoid plagiarism, to verify quotes, to show that you have researched the subject and to enable readers to follow up on what you have written and locate the work of the quoted author. Step in refers Keep a record of the full bibliographic details and relevant page numbers for all the sources from which information is taken Insert short quotes at the appropriate points in the text of your assignment. These are called in-text quotes Compiling a reference list at the end of the assignment that contains full details of all references quoted. Always check with your course coordinator, lecturer or supervisor about the bibliographic style that is preferred for your course. BibTeXBibTeX syles are usually part of a LaTeX template. Check the instructions to authors if the publisher offers a LaTeX template for this journal. Journal articlesThese examples include references to articles in scientific journals and how they should appear in your bibliography. Not all journals organize their published articles into volumes and problems, so these fields are optional. Some electronic journals do not provide a page range, but instead list an item identifier.
